The Rules for Sellers

_____ initial You can stay and sell/swap your gear or you can bring it in and put sale tags on it anytime the week prior to the swap meet. In that event, Gypsy Divers will attempt to sell the equipment for you, but makes no guarantee that we can do so. **YOU MUST PUT SALE TAGS ON EVERYTHING.**

_____ initial You must pick up any unsold equipment from Gypsy Divers by 5PM, April 9, 2022, or it becomes the exclusive property of Gypsy Divers to dispose of as they see fit.

_____ initial Gypsy Divers will charge a 20% consignment fee, payable by the seller, for all equipment sold during the swap meet. The fee will be collected from attending sellers at the end of the meet, or will be deducted from the sales proceeds from sellers who are not present.

_____ initial Gypsy Divers makes no opinion concerning the condition or value of any of the diving equipment offered during the swap meet, regardless of who the seller may be. Gypsy Divers is simply renting space on their premises to allow this sale, the compensation for which is the consignment fee collected. Gypsy Divers accepts no responsibility or liability for any equipment bought or sold during the swap meet, and does not and can not offer any kind of guarantee or representation as to the condition of any of the equipment offered during the swap meet. Gypsy Divers will have no part in any issues arising from the sale or purchase of equipment during the swap meet.
